## European Court of Human Rights Decisions

Decisions of the European Court of Human Rights (ECtHR) in 2009 brought good and bad news for conscientious objectors.

In April, in the case of *Glor v Switzerland*, the Court was scathing about the Swiss practice of imposing a supplementary "military tax" on of all men who do not perform military or alternative civilian service in a particular year.

In October, however, a Chamber of the Court upheld the conviction of Vahan Bayatyan, a Jehovah's Witness from Armenia, for his refusal to perform military service, arguing that conscientious objection to military service was not protected by the article of the European Convention on Human Rights dealing with freedom of thought, conscience and religion.

CPTI joined with four other international NGOs in submitting an Amicus Brief for the appeal to the full court, "the Grand Chamber". The appeal was heard on the 24th of November, just a few days ago. We await with interest the verdict, which will probably be published some time in the Spring of 2011.
